

Previous Sunday meeting, December 19th

The temperature climbed to 35° at 3.30 pm and winds gusted to 63km/h (34 knots), but by then we had retreated from the flying grit at GAN/Chauvel to the relative shelter of Malcolm's patch. Here he welcomed us to attack his thicket of Prickly Lettuce - though Rohan ranged wider beheading Verbascum - and Susan got to know more of the Ridge than Fencepost Hill where she has taken to spending her Fridays. Our ambition to assess fuel levels above GAN/Chauvel had already been thwarted as we searched fruitlessly for the star picket hammered in months earlier by Angela to mark the central plot. It (and possibly others along the Ridge) appears to have been harvested, making it impossible to proceed without GPS and co-ordinates. Gösta and I returned the following Tuesday with 4 wooden stakes to mark the north, east, south and west rectangles; the centre is now marked by a short metal stake. The stakes do not show above the long grass so it will always be necessary to locate the central one by GPS, and pace 50m by compass to the others. Nuisance. Then we measured fuel levels, which came out low in all 5 cases, and sent the data to Angela. O

Several of our Group responded to a request from a Chapman resident to attend a meeting called by the Weston Creek Community Council with Emergency Services, Rural Fire and CNP personnel.

Wednesday 22nd December at 4.30 pm of all times! In baking sunshine.

The official presenters spoke well, and listened to the concerns of the residents many of whom were clearly still very anxious and demanding action. Long grass was a commonly expressed worry even while ember attack from distant sources was acknowledged as a major threat.

It was generally accepted that in an emergency on the scale of the January 2003 fires official resources could never be adequate and that preemptive collaboration was vital. Suggestions covered whipper-snipping, slashing, grazing behind the houses, relaxed water restrictions so residents could keep their gardens lush, appropriate plantings, buckets, hoses and taps.


Lincoln resident Joe Walker spoke with the authority of his ecological and fire management background to balance some of the alarm expressed. He pointed out that cattle grazing will not necessarily reduce the threat from fires – grass height does not affect the rate of spread of a fire, only its intensity. Any grass-reduction efforts should be concentrated on the strip directly behind the houses.

CNP's Daniel Iglesias, East District manager, spoke passionately of ecological values, and of Cooleman Ridge as a precious community asset.

Gösta announced our January 18th Recovery Walk and handed round leaflets detailing it.. ♥
